

Mitchellville City Council Proceedings  
Regular Meeting – March 2, 2015

The Mitchellville City Council met in regular session at 7:00 pm in the council chambers of City Hall, 204 Center Ave. N., pursuant to notice.

Mayor Filbert called the meeting to order, roll call, members present: McGhee, Crook, Thomas, Zook and Engler.

Motion made by Engler to approve the tentative agenda, second by Crook. Motion carried unanimous

A motion by Thomas to approve the consent agenda paying claims of \$84,703.56 including 1 regular payroll, 2/16/2015 Council minutes, accepting Norman Veatch's resignation from the City Tree Board, and Library Board reports, which includes Board of Trustees 1/29/15 Minutes, Bills for Feb 2015, Jan. Monthly Stats and Feb. Directors Report. Motion was seconded by McGhee. Motion carried unanimous.

A motion made by McGhee to open the Public Hearing on the proposed city budget for fiscal year 2015-2016, second by Zook. Motion carried unanimous. Public Hearing was opened at 7:02 pm. Crook mentioned that the police had agreed to give up their request for a new car so they could have a greater adjustment to their salaries, and the special salary increase was not included in this proposal. A motion made by McGhee to close the Public Hearing, second by Crook. Motion carried unanimous. Public Hearing was closed at 7:03 pm.

Motion made by McGhee to approve Resolution 2015-16, adopting the City Budget for Fiscal Year 2015-2016, second by Thomas. Aye votes: McGhee, Thomas, Engler, Zook. Nays: Crook. Motion carried.

Alex Lynch with Eastern Polk Regional Development Incorporated introduced himself and gave updates.

Motion made by McGhee to approve Resolution 2015-17, authorizing the City Clerk to process certain bills, second by Thomas. Motion carried unanimous.

Motion made by McGhee to approve Resolution 2015-18, reappointing David Wieslander to the P&Z Commission, second by Crook. Motion carried unanimous.

Motion made by Thomas to approve Resolution 2015-19, appointing Neal Evans to the Board of Adjustment, second by McGhee. Motion carried unanimous.

Motion made by McGhee to approve Resolution 2015-20 appointing Byron Johnston to the City Tree Board, second by Crook. Motion carried unanimous.

Mayor Filbert is still working on the one open seat on the P&Z.

Department Heads, Council Members and the Mayor gave updates.

Mayor Filbert called for adjournment of the meeting. Meeting adjourned at 7:39 pm.
