

Mitchellville City Council Proceedings  
Regular Meeting, May 2nd, 2016 Minutes

The Mitchellville City Council met in regular session at 7:00 pm in the council chambers of City hall, 204 Center Ave N, pursuant to notice.

Mayor Woods called the meeting to order, roll call, members present: McGhee, Mitchell, and Sanger. Absent: Crook and Zook. The tentative agenda was amended to remove item # 11 discuss the city's participation in DART and to replace it with approval of June 6<sup>th</sup> as the public hearing date for voluntary annexation requests by IA-KY LLC, W. Edward Craig, President and Iowa Interstate Railroad. Motion made by McGhee, second by Mitchell, to approve the amended tentative agenda. Motion carried unanimous.

Motion by McGhee, second by Sanger, to approve the consent agenda, which approved payment of bills of \$72,435.31, including 1 regular payroll, 4-18-16 Council Minutes, Library Board of Trustees March 28, 2016 Minutes, April 2016 Library Stats, April 2016 Director's Report, and renewal of Casey's General Store #2177 liquor license (previously approved 8/17/2015) modified to include an upgrade to a class LE Liquor License. Motion carried unanimous.

Public Audience: Byron Johnston, 304 4<sup>th</sup> St NE, gave updates on Habitat for Humanity's June 16-18 project.

Motion made by McGhee, second by Sanger, to approve Resolution 2016-27, a letter of agreement between the Iowa Correctional Institute for Women and the City of Mitchellville for fire and rescue services. Motion carried unanimous.

Motion made by Sanger, second by McGhee, to approve Resolution 2016-28, approving a pay rate increase for public works employee Cory Eshelman. Motion carried unanimous.

Motion made by McGhee, second by Sanger, to approve Resolution 2016-29, approving a pay rate increase for public works employee Byron Vermie. Motion carried unanimous.

Motion made by Sanger, second by McGhee, to approve Resolution 2016-30, appointing Tammi Dillavou as interim city clerk and approving a pay rate increase. Motion carried unanimous.

Motion made by Sanger, second by Mitchell, to approve Resolution 2016-31, approving a job status change and pay rate increase for the utility billing clerk, Rahni Brose. Motion carried unanimous.

Council discussed the various ordinances relating to trees: Chapters 25, 151, 50, 62, and 135. Ordinances will be written with the recommended changes for discussion and approval at the next Council meeting.


